

**FERPA LOCAL SCHOOL DISTRICT OFFICIAL AGREEMENT  
BETWEEN  
GREEN BAY AREA PUBLIC SCHOOL DISTRICT, ASHWAUBENON SCHOOL  
DISTRICT, SCHOOL DISTRICT OF WEST DE PERE, DE PERE UNIFIED SCHOOL  
DISTRICT, DENMARK SCHOOL DISTRICT, PULASKI COMMUNITY SCHOOL  
DISTRICT, HOWARD-SUAMICO SCHOOL DISTRICT and WRIGHTSTOWN  
COMMUNITY SCHOOL DISTRICT  
AND  
BROWN COUNTY UNITED WAY, ACHIEVE BROWN COUNTY  
AND SYSLOGIC INC.**

This is an Agreement ("Agreement"), dated as of the date specified below, by and between GREEN BAY AREA PUBLIC SCHOOL DISTRICT, ASHWAUBENON SCHOOL DISTRICT, SCHOOL DISTRICT OF WEST DE PERE, DE PERE UNIFIED SCHOOL DISTRICT, DENMARK SCHOOL DISTRICT, PULASKI COMMUNITY SCHOOL DISTRICT, HOWARD-SUAMICO SCHOOL DISTRICT and WRIGHTSTOWN COMMUNITY SCHOOL DISTRICT, all Wisconsin school districts (collectively referred to as "Districts" or individually "District") and Brown County United Way and/or its affiliates ("BCUW"), Achieve Brown County ("ABC") and SysLogic Inc., ("SysLogic"), (each a "Party" and collectively the "Parties").

**RECITALS**

The Parties recite and declare as follows:

- A. WHEREAS, a school board may designate a contracted professional as a local school district official in order to have access to pupil records, where the contracted professional has a legitimate educational interest in said records; and
- B. WHEREAS, a local school district official performs functions, activities or services for, and on behalf of, the school district and the local school district official has access to pupil records in order to perform such functions, activities or services; and
- C. WHEREAS, a contracted professional designated to be a local school district official is prohibited from re-disclosing the pupil records; and
- D. WHEREAS, the Districts desire and authorize BCUW, ABC and SysLogic to provide services to the District in support of the Community Information System project (CIS) in order to identify students who may be entering its schools in need of support to be successful in their pursuit of graduating college, career and community ready; and
- E. WHEREAS, the Districts, BCUW, ABC and SysLogic recognize that BCUW, ABC and SysLogic must be provided certain "directory data" and "education record" information as such terms are defined by Family Educational Rights and Privacy Act (FERPA), 20 U.S.C. 1232g, *et seq* and Wis. Stat. § 118.125 for the providing of such services. The Districts agree

in accordance with the terms and conditions set forth herein to provide the following information to BCUW, ABC and SysLogic:

File 1 - Directory Data (uploaded to the CIS project's secure file server) with the following data:

- i. First, Last and Middle (where applicable) name of students age 3 to 21 years of age enrolled in the District for school year 2019-2020;
- ii. The date of birth for the students;
- iii. The home address of the students;
- iv. The dates of attendance of the students; and
- v. GBAPS assigned arbitrary identification number to be used later.

F. WHEREAS, the Parties desire to work together to provide such services to the Districts as set forth below.

NOW THEREFORE, in consideration of the mutual agreements set forth in this Agreement, the Parties agree as follows:

1. FERPA. In accordance with the Family Educational Rights and Privacy Act (FERPA), the following shall apply:
  - a. In the course of providing services during the term of the Agreement, BCUW, ABC and SysLogic shall have access to the identified student education records that are subject to the FERPA, 20 U.S.C. 1232g, *et seq.* and Wisconsin statute 118.125, and the regulations promulgated there under. Such information is considered confidential and is protected. To the extent that BCUW, ABC and SysLogic have access to "education records" under this contract, if it is deemed necessary, BCUW, ABC and SysLogic shall be deemed a "school official" as such term is defined under FERPA and Wisconsin law. BCUW, ABC and SysLogic agree that they shall not use education records for any purpose other than in the performance of this contract. Except as required by law, BCUW, ABC and SysLogic shall not disclose or share education records with any third party unless permitted by the terms of the contract or to pre-agreed upon subcontractors who have agreed to maintain the confidentiality of the education records to the same extent required of BCUW, ABC and SysLogic under this contract.
  - b. SysLogic, in order to protect student privacy, will only provide a student subject number connected to address information only to the Medical College of Wisconsin, United Way or ABC for the purpose of data analysis. Any other file sharing will not disclose the student address with a de-identified student subject number in order for the student to remain de-identified and the achievement data not traceable to a specific student.
  - c. In the event any person(s) seek to access protected education records beyond the access that is provided to covered BCUW, ABC and SysLogic employees for purposes of providing such services to the Districts, whether in accordance with FERPA or other Federal or relevant State law or regulations, BCUW, ABC, and SysLogic will immediately inform the applicable District or Districts of such request in writing if



allowed by law or judicial and/or administrative order. BCUW, ABC and SysLogic shall not provide direct access to such data or information or respond to individual requests. BCUW, ABC and SysLogic shall only retrieve such data or information upon receipt of, and in accordance with, written directions by Districts and shall only provide such data and information to Districts. It shall be each District's sole responsibility to respond to requests for data or information received by BCUW, ABC and SysLogic regarding that District's data or information. Should BCUW, ABC or SysLogic receive a court order or lawfully issued subpoena seeking the release of such data or information, BCUW, ABC or SysLogic shall provide immediate notification to the applicable District or Districts of its receipt of such court order or lawfully issued subpoena and shall immediately provide such Districts with a copy of such court order or lawfully issued subpoena prior to releasing the requested data or information, if required by law or judicial and/or administrative order.

- d. If BCUW, ABC or SysLogic experiences a disclosure or security breach concerning any education record covered by this contract, BCUW, ABC or SysLogic shall immediately notify the affected District or Districts and take immediate steps to limit and mitigate such security breach to the extent possible. The parties agree that any breach of the privacy and/or confidentiality obligation set forth in the contract may, at Districts' discretion, result in cancellation of further consideration for contract award and the eligibility for BCUW, ABC or SysLogic to receive any information from Districts for a period of not less than five (5) years. In addition, BCUW, ABC and SysLogic agree to indemnify and hold Districts harmless for any loss, cost, damage or expense suffered by Districts, including but not limited to the cost of notification of affected persons, as a direct result of the unauthorized disclosure of education records.
  - e. Upon termination of this contract, BCUW, ABC and SysLogic shall return and/or destroy all data or information received from Districts upon, and in accordance with, direction from the Districts. BCUW, ABC or SysLogic shall not retain copies of any data or information received from a District once a District has directed BCUW, ABC or SysLogic as to how such information shall be returned to District and/or destroyed. Furthermore, BCUW, ABC and SysLogic shall ensure that they dispose of any and all data or information received from Districts in a District-approved manner that maintains the confidentiality of the contents of such records (e.g. shredding paper records, erasing and reformatting hard drives, erasing and/or physically destroying any portable electronic devices). BCUW, ABC and SysLogic further agree to destroy all undistributed copies of analysis results.
2. Use of Subcontractors and Agents. BCUW, ABC and SysLogic shall require each of its agents and subcontractors that receive pupil records from BCUW, ABC or SysLogic to comply with all the terms of this Agreement.
  3. Term. The term of the Agreement shall have commenced effective the date of execution and shall expire June 30, 2021.

4. Termination. In addition to and notwithstanding any termination provision set forth in the underlying agreement(s), in which the Districts share pupil records with BCUW, ABC and SysLogic, this Agreement and such underlying agreement(s) may be terminated by the Districts if BCUW, ABC and SysLogic fail to cure such breach within thirty (30) days of receiving written notice from the Districts of such breach (or such longer time necessary to cure such breach if the breach cannot be cured in (30) days). The Party in breach shall identify to the non-breaching Party all steps taking to cure such breach and the estimated timeframe for such cure.
5. Indemnification. BCUW, ABC and SysLogic shall indemnify the Districts and their board members, officers, agents, subcontractors, and employees, from any and all claims, losses, suits or liability, including reasonable attorneys' fees for damages or costs resulting from the acts or omissions of BCUW, ABC or SysLogic, or its board members, officers, agents, subcontractors and employees while performing this Agreement or malpractice or personal injury claims from any students or parents.
6. Notices. Any notice required or permitted to be given by the terms of this Agreement or under any applicable law by any Party shall be in writing and shall be either hand delivered or sent by certified or registered mail, postage prepaid, return receipt requested. 7. Miscellaneous. This Agreement may be modified only by an instrument in writing signed by all Parties. This Agreement shall be binding upon and inure to the benefit of the Parties hereto, their respective successors and assigns. The waiver of any breach of any term or condition hereof shall not be deemed a waiver of any other or subsequent breach, whether of like or of different nature. The captions contained herein are not part of this Agreement, are only for the convenience of the Parties and do not modify, amplify or give full notice of any of the terms, covenants and conditions of any articles, paragraph, clause or provisions of this Agreement. This Agreement shall be interpreted and construed in accordance with the laws of the State of Wisconsin and any legal action shall be venued in Brown County, Wisconsin. The invalidity or unenforceability of any provision hereof shall not affect the validity or enforceability of the remainder of this Agreement. Whenever used herein, the singular form

shall include the plural and vice versa, and the use of any gender shall include all genders, as appropriate.

8. Entire Agreement. This Agreement and any exhibits attached hereto contain the entire Agreement between the Parties. There are no promises, agreements, conditions, undertakings, warranties or representations, oral, written, express or implied, between the Parties other than as herein set forth.

9. Assignment. BCUW, ABC or SysLogic may not assign or transfer any of its rights under this Agreement without the written consent of Districts.






